



## Town of Buena Vista Art Gallery Liquor Permit

*A liquor permit for businesses that qualify as an art gallery.*

This permit allows for service of complimentary alcohol, only at specific dates and times, and within the limits of Colorado statutes.

The Colorado Liquor Code defines an “Art Gallery” as an establishment whose primary purpose is the display and sale of works of fine art, and precious or semi-precious metals or stones. “Works of fine art” may include, but is not limited to painting, sculpture, drawing, mosaic, photography, calligraphy, graphic art, or craft work in materials such as clay, textile, fiber, wood, metal plastic or glass.

### Art Gallery Permit F.A.Q.s

*Does my business qualify as an Art Gallery and how will my eligibility be determined?*

Applications will be reviewed by the Town Clerk and applicants may be required to appear before the local Liquor Licensing Authority Board to establish that the business qualifies as an Art Gallery and that the applicant can serve complimentary alcohol beverages without violating the liquor code or creating a public safety risk to the neighborhood.

*What does the Art Gallery Permit allow?*

Permits are good one year from the date issued, but only for the dates and times listed in the application. You may apply for up to 15 dates a year and may serve for up to 4 hours on any given date. The dates and times may not be changed except by 15 days prior notice to the local and state liquor authorities. You may not charge for alcohol. A new application must be filed for each new permit year.

*How much are the fees for the permit?*

Fees to the State are \$71.25 and to the Town are \$103.75 per year, payable with the application. There is no additional fee per event.

### How do I apply for an Art Gallery Permit?

Obtain an application (Colorado Form DR 8443), available at the Town Clerk's office, or online at

Submit the completed form to the Town Clerk's office. Attach to the form:

- An 8 ½"x11" detailed diagram, (outlined in black marker) of the premise that accurately reflects the area(s) where alcohol will be stored, served, possessed or consumed (does not have to be drawn to scale);
- A copy of your lease or deed, showing that you have possession of the premise for at least the term of the permit.
- A check payable to the Colorado Department of Revenue for \$71.25, or the Colorado Department of Revenue now accepts state fee payments online. **To take advantage of the quick turnaround time made possible by this process, please follow these steps:**
  1. Go online to <https://secure.colorado.gov/payment/liquor> and pay the state fee directly to CDOR. Print out your receipt.
  2. Submit the completed Art Gallery Permit Application, your receipt from the CDOR, and your check a check payable to the Town of Buena Vista for \$103.75
  3. The Town Clerk will review your application and submit it to the state electronically.

If you prefer, you can submit your application and both state and town payments to the Town Clerk directly, and we will handle your license renewal via regular mail. This process may extend the time it takes to receive your license.

### May I charge for drinks?

**NO.** An Art Gallery Permit *only* allows the applicant to serve complimentary alcohol beverages. You may not sell alcohol, nor charge an entrance fee or a cover charge in connection with offering complimentary alcohol beverages.

### Can a non-profit still hold a Special Event at my location?

Yes. Special Event permits are separate from Art Gallery Permits. The Special Event permit is only available to non-profits and the process for obtaining it has not changed. You may continue to host Special Events in addition to your Art Gallery Permit, but not during the times listed on your permit. The non-profit applicant must apply for the permit and must have possession of your premise during the Special Event.

### Must I serve food when I serve alcohol?

No, the law does not require that you serve food with an Art Gallery Permit.

How long will it take to receive approval of my application?

Please submit your application at least 45 days prior to your first scheduled event to assure sufficient processing time.

May I purchase liquor from a licensed wholesaler once I am granted an Art Gallery Permit?

You may purchase your inventory from licensed wholesalers, or from retail liquor stores.

What regulations will I be subject to once I obtain an Art Gallery Permit?

Art Gallery Permittees are subject to **ALL** of the requirements and restrictions of the state and local liquor codes and are subject to the same penalties as other licensees. An Art Gallery Permit may be suspended or revoked for violation of any provision of the liquor codes. Reference materials are listed below for you to familiarize yourself with these regulations. A few of the major provisions to keep in mind are:

- Consumption of alcohol is limited only to the licensed premise and unconsumed alcohol may not be taken off of the premise;
- You may not charge for alcohol, directly or indirectly;
- No more than 250 people may be on the licensed premise at any one time while alcohol is being served;
- The minimum age of any person serving alcohol beverages is 21.  
You may be required to attend a alcohol server training class
